BASIS OF BEARING

THE BASIS OF BEARING FOR THIS SURVEY IS GEODETIC NORTH AT FIRST ORDER TRIANGULATION STATION EAST CONTROL (LAWD) 1934. A GEODETIC NORTH AZIMUTH AT EAST CONTROL TO WEST CONTROL OF 303° 45' 52" WAS DERIVED FROM INFORMATION PUBLISHED BY THE COAST AND GEODETIC SURVEY IN JULY 1979. A WILD T 2 WAS SET OVER EAST CONTROL AND A BACK SIGHT WAS TAKEN ON FIRST ORDER TRIANGULATION STATION WEST CONTROL (LAWD) 1933. HORIZONTAL AND VERTICAL ANGLES WERE TURNED TO THREE POINTS USED IN THE CONTROL TRAVERSE FOR THE SUBDIVISION OF SECTION 19. SLOPE DISTANCES WERE MEASURED WITH A H.P 3800 E.D.M.


