

PIPE AND CAP STAMPED AS SHOWN.
- ⑦ FD. ROTTED REMAINS OF 4" WOOD POST IN ROCK MND. PER R, FROM WHICH BEARS A 32" JEFFREY PINE ROTTED STUMP S 24°10' E 59.8' (M) - 24" YELLOW PINE S 21 1/2° E 90 LNKS (R), AND FROM WHICH BEARS THE ROTTED REMAINS OF A STUMP S 80°27' W 26.2' (M) - 10" FIR S 81° W 43 LNKS (R), REPLACED POST WITH 2" AL. PIPE AND CAP STAMPED AS SHOWN.

- ⑨ POST IN ROCK MND. AND 12" MAHOGANY BEARING TREE PER R NOT FD., FD. 16" MOUNTAIN MAHOGANY, 10" X 6" OPEN BLAZE, BEARING TREE - 15" MAHOGANY N 16° E 44 LNKS (R), RESET 1/4 COR. FROM FD. BEARING TREE, S 16°00' W 29.04' (CFR), WITH 2" AL. PIPE AND CAP STAMPED AS SHOWN.
- ⑩ FD. ROCK MND., NO REF., IN LIEU OF EARTH MND. PER R, WOOD POST AND YELLOW PINE BEARING TREE PER R NOT FD., ACCEPTED AS 1/4 COR. AND SET 2" AL. PIPE AND CAP IN ROCK MND., STAMPED AS SHOWN.
- ⑪ FD. 2" I.P. WITH PLUG AND NAIL, NO REF., AT INTERSECTION OF OLD N-S AND E-W BARBED WIRE FENCE, NO EVIDENCE OF ORIG. WOOD POST IN EARTH MND. PER R, (NO BEARING TREES OF RECORD), ACCEPTED I.P. AS SEC. COR. AND ADDED TAG, "LS 4587".
- ⑫ 4" WOOD POST IN EARTH MND. AND TWO MAHOGANY BEARING TREES PER R NOT FD., REESTABLISHED 1/4 COR. BY SINGLE PROPORTION (SHOWN HEREON) BETWEEN MON. #S 7 AND 11 ABOVE, SET 2" AL. PIPE AND CAP STAMPED AS SHOWN.
- ⑬ FD. 4" WOOD POST IN ROCK MND. PER R, REPLACED POST WITH 2" AL. PIPE AND CAP STAMPED AS SHOWN.
- ⑭ STONE IN STONE MND. PER R NOT FD., (NO BEARING TREES OF RECORD), REESTABLISHED SEC. COR. BY DOUBLE PROPORTION (SEE SHEET 1) BETWEEN MON. #S 8,9,10 AND 13 ABOVE, SET 2" AL. PIPE AND CAP STAMPED AS SHOWN.
- ⑮ STONE IN STONE MND. AND ASPEN BEARING TREE PER R NOT FD., NOTHING SET.
