

NOTE: THIS SURVEY OF GOVERNMENT LOT 9, SECTION 35, IS DONE PER THE RECORD PLAT OF NOV. 20, 1981. THE ORIGINAL TOWNSHIP SURVEY BY VON SCHMIDT IN 1853 WAS INCOMPLETE, TERMINATING ON THE NORTH LINE OF SECTION 35. THEREFORE, THE NORTH HALF OF SECTION 35 IS A FRACTIONAL BREAKDOWN.
