




22 SET (JNP) 20" IN GROUND IN 3 1/2' DIA. BY 8" HIGH ROCK MOUND. CAP STAMPED:





24 SET (JNP) 18" IN GROUND IN 3' DIA. BY 10" HIGH ROCK MOUND. CAP STAMPED:



SECTION CORNER 4 | 3 BEARS WEST 1611.72' AND 1/4 CORNER TO SECTIONS 31/32 BEARS NORTH 6549.18' MEASURED BEARING AND DISTANCE TO 4 | 3 IS N.89°38'57"W. 2229.79' AND TO 1/4 SECTION 31/32 IS N.05°21'24"W. 6675.47'. NOT ACCEPTED AS CLOSING CORNER, SEE 28
