THE SOUTH HALF OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 19; THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 19; THE SOUTH HALF OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 20; THE WEST HALF OF THE SOUTHWEST QUARTER OF SECTION 20; THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 29; AND THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 30, ALL IN TOWNSHIP 2 SOUTH, RANGE 31 EAST, M.D.B.&M., IN THE COUNTY OF MONO, STATE OF CALIFORNIA.

- A** FD. 12" PINE PER ORIGINAL NOTES (R1, 8") DEAD AND DOWNED WITH BLAZE AND POSSIBLE SCRIBES ON THE BOTTOM SIDE. SET REBAR W/ALUMINUM CAP STAMPED "LS 4587" IN CENTER OF ROOT IMPRESSION, ATTACHED BEARING TREE LOCATION POSTER TO TREE. CORNER FIT WELL WITH TOPO CALLS IN ORIGINAL NOTES (R1)
- B** FD. ROCK MOUND, & WOODY MATERIAL 4" BELOW SURFACE. FD. 2 BEARING TREES PER ORIG NOTES (R1) WITH OPEN BLAZES AND LEGIBLE SCRIBES. SET REBAR AND ALUM. CAP STAMPED "LS 4587" IN CENTER OF MOUND. ATTACHED BEARING TREE LOCATION POSTER TO BOTH BEARING TREES.
- C** FD. 26" PINE (14", R1), BLAZED ON NORTH SIDE, SCRIBED 1/4 ON SOUTH SIDE. SET SPIKE & WASHER STAMPED "LS 4587" AT SPLIT IN TREE. SET BEARING TREE LOCATION POSTER ON EAST SIDE OF TREE.
- D** FD. 16" DOUBLE PINE WITH HACKED BRANCHES FD. LYING 4" BELOW GROUND SURFACE. FD. 14" STUMP CUT WAIST LEVEL N25°W 10' (N5°W 9.2', R1), FD. 14" PINE S32°W 46.5' (S20°30'W 45.5' R1), ACCEPTED AS 1/4 CORNER, SET SPIKE WITH RED PLASTIC CAP & WASHER STAMPED "LS 4587" AT SPLIT IN DOUBLE PINE.
- E** FD. 2 LARGE STONES, POST & "NATIONAL FOREST BOUNDARY" & "FOREST ADMINISTRATIVE SITE" SIGNS APPROXIMATELY 50 YEARS OLD. ACCEPTED AS SECTION CORNER, SET REBAR W/ALUMINUM CAP STAMPED "LS 4587"
- F** FD. ROCK MOUND, FD. 12" & 8" BEARING TREES PER ORIGINAL NOTES (R2), WITH USFS BEARING TREE LOCATION POSTERS MARKED "1/4 COR. ROCK MOUND 7-24-47 CMS" ON BOTH TREES. SET REBAR W/ALUMINUM CAP STAMPED "LS 4587" IN CENTER OF MOUND.
- G** FD. ROCK MOUND, FD. 4 BEARING TREES PER ORIGINAL NOTES (R2). SET REBAR W/ ALUM. CAP STAMPED "LS 4587" IN CENTER OF MOUND.
- H** FD. ROCK MOUND AND BEARING TREE PER ORIGINAL NOTES (R2), SET REBAR W/ALUMINUM CAP STAMPED "LS 4587" IN CENTER OF MOUND, SET BEARING TREE LOCATION POSTER TO BEARING TREE.
- I** FD. ROCK MOUND AND ORIGINAL 25"x10"x9"STONE WITH 5 NOTCHES ON EAST SIDE AND 2 NOTCHES ON SOUTH SIDE. WIRED TAG "LS 4587" TO STONE.
- J** FD. ROCK MOUND & ORIGINAL 15"x10"x4" STONE MARKED "1/4" ON EAST FACE, FD. 2 BEARING TREES PER ORIGINAL NOTES (R2), WIRED TAG "LS 4587" TO STONE. ATTACHED BEARING TREE LOCATION POSTER TO 14" PINE N47°45'E (R2), 24" PINE S50°30'W (R2) IS STANDING DEAD WITH VISIBLE SCRIBES.
- K** FD. LARGE ROCK MOUND & ORIGINAL 21"x10"x6" STONE, FD. 2 BEARING TREES PER ORIG. NOTES (R2), REMOVED CENTER STONE SET REBAR W/ALUM CAP "LS 4587", DEPOSITED STONE ALONGSIDE. ATTACHED BEARING TREE LOCATION POSTER TO 12" PINE S1°30'E, DEAD AND DOWNED WITH VISIBLE SCRIBES.
- L** FD. ROCK MOUND WITH "OLD" 2X2 HUB & TACK IN CENTER OF MOUND. FD. 2 BEARING TREES PER ORIG. NOTES (R2). SET TAG "LS 4587" IN 2X2 HUB, ATTACHED BEARING TREE LOCATION POSTERS TO BOTH BEARING TREES, 24" PINE N48°W, DEAD AND DOWNED WITH VISIBLE SCRIBES.
- M** FD. 20"x17"x8" ORIGINAL STONE MARKED "1/4" ON NORTH FACE, FD. LEAD & TAG "LS 4516" IN TOP CENTER OF STONE. FD. 2 BEARING TREES PER (R2) BLAZES GROWN OVER, BEARING TREE LOCATION POSTERS PER (R3)
- N** FD. 2" IP & BRASS CAP "LS 4516" STAMPED PER (R3). FD. 24" PINE S76°E 183.5' (S74°15'E 182.2' R2) WITH VISIBLE SCRIBES DEEP INTO GROWN OVER BLAZE, BEARING TREE POSTER PER (R3), FD. 12" PINE N83°E 215.5' (N76°15'E 185.46' R2) WITH BEARING TREE LOCATION POSTER PER (R3) AND NO VISIBLE BLAZE, ACCEPTED BRASS CAP AS SECTION CORNER.
- O** NOTHING FOUND, ORIGINAL NOTES (R2) (TYPE WRITTEN AND ORIGINAL HANDWRITTEN NOTES) HAVE IDENTICAL DESCRIPTIONS FOR CORNERS "N" AND "O". BEARING TREES PER NOTES (R2) WERE FOUND AT CORNER "N". CALCULATED 1/4 CORNER POSITION BY SINGLE PROPORTION, NOTHING SET.
- P** FD. ROCK MOUND WITH 14"x12"x4" ORIGINAL STONE, 4 GROOVES ON EAST SIDE, 1 GROOVE ON SOUTH SIDE. FD. 4 BEARING TREES PER ORIGINAL NOTES (R2). WIRED TAG "LS 4587" TO STONE. ATTACHED BEARING TREE LOCATION POSTER ON DEAD LIMB OF 10" PINE S71°E NEXT TO VISIBLE SCRIBES.
- Q** FD. ROCK MOUND, & WOODY MATERIAL 1' BELOW SURFACE. EVIDENCE OF RECENT WILDFIRE IN AREA. ACCEPTED AS 1/4 CORNER, SET REBAR AND ALUM. CAP "LS 4587" IN CENTER OF MOUND.
- R** CALCULATED BY SINGLE PROPORTION. NOTHING SET. FD. 24" PINE GNARLED AND TWISTED, WITH APPARENT RECENT HACK MARKS AT BASE OF TREE ON SOUTHWEST FACING SIDE ATTEMPTING TO REVEAL ORIGINAL BLAZE. THE HACK MARKS APPEAR TO BE 10-15 YEARS OLD, WE ATTEMPTED TO OPEN UP BLAZE MORE, IT REVEALED NOTHING, DID NOT ACCEPT AS ORIGINAL ACCESSORY, N13°E 185' FROM CALCULATED POSITION OF CORNER. 12" PINE S46°W 57.42'(R2), 24" PINE N52° 76.56' (R2) NOT FD.
- S** NOTHING FOUND, CALCULATED POSITION BY SINGLE PROPORTION. NOTHING SET.
- T** FOUND 8" DIAMETER POST WITH HEWN SQUARE EDGES AND FLATTENED FACES ON 4 SIDES, SET PER (R1), SET 2"IP WITH ALUMINUM CAP STAMPED "LS 4587"
