### BASIS OF BEARING:

THE BASIS OF BEARINGS FOR THIS SURVEY IS THE CALIFORNIA COORDINATE SYSTEM 1983, ZONE 3, BEARING NORTH 89° 18' 08" EAST, BETWEEN THE SOUTHEAST CORNER OF SECTION 25, TOWNSHIP 4 NORTH, RANGE 25 EAST, M.D.B. & M. AND THE SOUTHWEST CORNER OF SECTION 36, TOWNSHIP 4 NORTH, RANGE 25 EAST, M.D.B. & M. THE COORDINATES OF SAID POINTS BEING ESTABLISHED BY A G.P.S. SURVEY INCORPORATING CALIFORNIA H.P.&N STATIONS CONWAY AND BRIDGEPORT INTO THE CONTROL NETWORK. ALL COORDINATES, BEARINGS, AND DISTANCES SHOWN ARE IN GRID U.S. SURVEY FEET. TO CONVERT GRID DISTANCES TO GROUND DISTANCES DIVIDE THE GRID DISTANCE BY THE COMBINED GRID FACTOR 0.999599809.
